

AMPAC TOURS / TERMS & CONDITIONS - PLEASE READ CAREFULLY

Reservations. All reservations for the packages shown herein may be made through travel agents. A non-refundable booking fee of \$200 is required to request services. Payment of booking fee constitutes acceptance of these terms and conditions.

Deposit. Upon confirmation of services a deposit equal to 20% of your total tour fare or \$300 per person, whichever is greater is required within 14 days to hold your reservation. Your booking fee will be applied towards your deposit.

Late Bookings. Reservations made within 30 days prior to departure from the United States are considered late bookings and require full payment at time of booking. A \$50 late booking fee will be charged to cover the cost of special handling.

Final Payment. Final payment is due 60 days prior to departure. We accept checks, money orders, Visa, MasterCard and American Express. Credit card charges will not be processed without a signed authorization form and credit card copy. Some air inclusive tours require final payment within 14 days of confirmation.

Change Fee. A change fee of \$50 per change will be charged if the change is made after confirmation and before issuance of documents. Changes made after documents are issued, will be charged a \$75 per change handling fee. If such changes necessitate cancellation of confirmed air or ground arrangements, unrecoverable costs will be added to the change fee.

Cancellations & Refund. All cancellations must be made in writing and the date of receipt of said cancellation will determine what penalties are to be assessed. The following per person penalties will apply to any cancellation based upon how many business days prior to the first date of service written notice is received by us. Business days are Monday through Friday excluding

public holidays. Day of booking to 60 business days prior to first date of service: Deposit. Cancellations received in writing within 60 business days of the first date of service, the following cancellation charges apply: 59-45 business days, 35% of tour cost; 44-30 business days, 60% of the tour cost; 29-8 business days, 85% of the tour cost. Less than 8 business days & no show, 100% of tour fare. (Percentage penalties based on total tour price for your customized itinerary.)

Special cancellation policies may apply if rail or cruise travel is included. There is no refund for unused services after tour commencement.

Booking & special handling fees are non-refundable.

Custom Itineraries & Special Group Tours: Deposit and cancellation terms as specified on your invoice.

Air Transportation. When air fare is included, the air portions of the tours will be provided as part of the total package and issued as such by Ampac Tours. Air fare is based on Economy Class service. Voluntary changes to travel dates and/or routing may require a recalculation of air fare. All fares used in the package prices are effective August 01, 2009 and are subject to change. Once transportation has begun, there will be no refund if you do not use the flights as scheduled. Nor will any unused coupons be transferrable as credit towards purchase of any other air fare, unless applicable air tariffs permit the same. Some types of air fare, once tickets are issued, are non-refundable.

Air Fare Cancellation Fees. Per person cancellation fees on the air portion of your reservation will be assessed based on the air fare type booked for your flight arrangements. Please note that some air fare types are non-refundable. Any change in flight itinerary, travel date, passenger name or class of service is considered a cancellation and will incur applicable cancellation fees. Please be sure to

verify all applicable airfare cancellation fees with your travel agent at time of booking.

Air Tickets, Hotel & Tour Vouchers. Air tickets, hotel and tour vouchers will not be issued until full payment is received. Express air delivery service is available upon request at a charge of \$50 per booking (lower 48 states) and \$75 per booking (Alaska & Hawaii). Express service is recommended for bookings made within 30 days of departure.

Tour Prices. Tour prices are quoted in US dollars, per person, on a double occupancy basis, and are based on tariffs, costs, schedules and rates of exchange between US dollars and foreign currencies in effect August 01, 2009. Any fluctuation of air fare, land prices or currency exchange rates could result in a higher tour cost.

Travel Insurance. We recommend that passengers, for their own protection and peace of mind, insure themselves against trip cancellation, accident and baggage loss. To maximise your coverage, insurance must be purchased within 14 days of your initial trip deposit/payment. Trip cancellation insurance is available for purchase on our web site: www.ampactours.com or from your travel agent.

Hotels. All hotels are subject to availability. Triple rooms usually consist of two twin beds plus a roll-away bed.

Transfers & Sightseeing. Transfers to and from airports and hotels, and sightseeing will be done by private vehicle, taxi, or private motorcoach on a seat-in-coach basis and regular sightseeing boat as specified in each tour module or on your invoice.

Baggage. Baggage is at "owner's own risk" throughout the tour. Ampac Tours is not responsible for lost or damaged baggage. Airline Baggage allowance is subject to change. Please contact the airline directly for baggage allowance.

Not Included. The tour fare does not include meals unless specifically indicated in itinerary, optional tours, charges for passports, visas, vaccinations, inoculations, laundry, liquor, excess baggage charges, accident and baggage insurance, telephone or cable charges, items of a personal nature, and any items not specifically listed as included.

Health Requirements. Currently none of the countries included in the itineraries require a certificate of vaccination. However, this is subject to change at any time. Therefore, before traveling, check to be sure you have the latest information regarding immunization requirements. It is the passenger's responsibility to take all precautions with regard to health regulations.

Taxes, Services & Gratuities. Tour prices include government and local taxes and service charges on all services included in the itinerary. Foreign Airport Departure Taxes are NOT included in the tour price and are the responsibility of each passenger unless otherwise stated as included. Customary gratuities to tour guides/local hosts and drivers are not included. Any such expression of appreciation should be offered on a voluntary and personal basis (\$2-\$5 per person/per day for guide/local host & \$1-\$2 for driver).

Handling Charges. Please note that all prices quoted include handling charges imposed by Ampac Tours and our local agents. Handling charges cover the cost of communications between Ampac Tours and our overseas local operators as well as financial transactions and currency fluctuations between the time of booking and the actual date of services rendered, the preparation and shipping of passenger documentation and the promotion of the programs.

Travel Documents. A valid passport is required for all tour participants. Your passport must have adequate blank pages for entry/exit stamps. Most countries require your passport to be valid for a period of six months after your scheduled return date. Visas are required for U.S. citizens visiting Indonesia, India, Bhutan, Vietnam, Cambodia, Laos, Myanmar and the People's Republic of China. Nationals of other countries should check with the respective Consul General office for visa requirements. It is the responsibility of individual passengers to obtain visas. Ampac Tours will not be responsible for any additional charges resulting from improper documentation.

Maps. Maps shown on tour pages are for general information, are not to scale and may not accurately reflect actual routing.

Responsibility. Ampac Tours International, Inc. 16524 7th Place West, Lynnwood, WA 98037, gives notice that all tickets and vouchers issued by them and all arrangements for transport or conveyance or hotel accommodations are made by them as agents upon the expressed condition that Ampac Tours shall not be liable for any injury, damage, loss, accidents, delay or irregularity which may be occasioned, either by reason or by defect in any vehicle, or through the act or default of any company or person engaged in conveying the passenger(s), or in carrying out the arrangements of the tour(s), or otherwise in connection therewith, or of any hotel proprietor or services, sickness, weather, strikes, force majeure, war, acts of terrorism, quarantine, other causes or acts of God. All tour itineraries and prices may be affected by alterations in steamship, air or railroad services of the various countries or by other causes. The right is reserved to withdraw any tour announced in this brochure, substitute hotels, and to make such alterations in the itineraries as may be found desirable for the convenience of the parties and the proper carrying out of the tour(s).

All prices shown are in U.S. DOLLARS and are based on the present value of foreign currencies in relation to the U.S. Dollar, and, in current tariffs, and are subject to confirmation or adjustment (either way) until final payment is received by Ampac Tours. The right is reserved to cancel the tour prior to departure. In such case, refund of all monies received will constitute full settlement with the passenger. The right is also reserved to decline to accept or retain any person as a member of any tour at any time.

The airlines concerned are not held responsible for any act, omission, or event during the time passengers are not on board their planes or conveyances. The passengers' contract in use by the airlines concerned, when issued, shall constitute the sole contract between the airlines and the purchaser of these tours and/or passenger(s). Any and/or all transportation companies herein mentioned shall have or incur no responsibility or liability to any traveler aside from their liability as common carriers.
